APPLICATION AND REQUIREMENT FORM

Application Deadline: This form including required information must be submitted two weeks prior to scheduled meeting.

- A. Submit complete application in duplicate, including site plan and architectural plans consisting of the ground or first floor plan, *roof plan if required, and all exterior elevations to: Village Hall, 7 Stage Road, Monroe, NY 10950, Attn: AARB
- B. Submit one complete application (same as above) to each board member.
- C. Application fee. (See attached fee schedule)

The following check list is to be completed and samples to be available at the hearing
These items will become part of the record and will not be returned to applicant

- 1 - Description of proposed finish material including colors and samples.
- 2 - Photographs of adjacent property.
- 3 - Handicap accessibility, all types of screening, retaining walls, landscaping.
- 4 - Finish elevations to show chimney, *mechanical equipment if roof mounted, vents, signs, lighting and any type of equipment that may be visible.

Sign Applications

- 1 - Must include an elevation of the structure illustrating placement and method of attachment of the sign.
- 2 - Description of proposed finish material, including colors, method of illumination and samples.

* **NOTE:** If this application is an addition or change to an existing building, the structure as a whole must be shown and all the above requirements shall apply.

LOCAL LAW #4 of 1996
CODE AMENDMENT - ARCHITECTURAL APPEARANCE REVIEW BOARD FEE

PLEASE TAKE NOTICE that the Board of Trustees of the Village of Monroe at their July 2, '1996 Meeting did adopt Local Law #4 of 1996 amending Local Law #2 of 1992 - Fee Schedule, by amending Section 3, Fee Schedule & Escrow Deposits, 5. Architectural Appearance Review Board Fee, by deleting the current application fee of \$100 and adopting the following:

1. The minimum fee for the Architectural Appearance Review Board is twenty dollars (\$20) plus five dollars (\$5) per thousand dollars (\$1,000) of estimated project cost. The maximum fee will not exceed two hundred fifty dollars (\$250).

This Local Law shall take effect upon filing with the Secretary of State.
