VILLAGE OF MONROE

LOCAL LAW NO. 2 of 2022 AMENDING THE ADMINISTRATIVE LEGISLATION OF THE VILLAGE OF MONROE BY ADDING CHAPTER 58, TITLED, "RESIDENCY REQUIREMENTS" TO EXPAND RESIDENCY REQUIREMENTS FOR APPOINTED VILLAGE OFFICIALS

BE IT ENACTED by the Village Board of Trustees of the Village of Monroe, County of Orange, State of New York, as follows:

- **Section 1.** Legislative Findings, Purpose and intent. The Village Board of Trustees finds and determines that it is not always possible to fill certain appointive offices and nonjudicial positions in Village government requiring municipal, administrative or financial expertise with Village residents who are duly qualified to hold such positions and that by expanding the residency requirements from Village-only residents to any resident residing in the County of Orange, wherein the Village wholly lies, would further the goal of better and more responsive government.
- **Section 2.** Authority. This local law is enacted by the Village Board of Trustees of the Village of Monroe pursuant to its authority to adopt local laws pursuant to the New York State Constitution and Section 10 of the Municipal Home Rule Law and authority granted it under § 3-300 of the Village Law.
- **Section 3.** The Administrative Legislation of the Code of Village of Monroe is hereby amended by the addition of Chapter 58, titled, "Residency Requirements," as follows:

Chapter 58 Residency Requirements

Article I

Village Clerk; Deputy Clerk; Treasurer; Deputy Treasurer; Village Assessor; Deputy Assessor; Court Clerk; Assistant Court Clerk; Election Inspectors

§ 58-1 Purpose; legislative authority.

The Board of Trustees finds that it is not always possible to fill certain appointive offices and nonjudicial positions in Village government requiring municipal, administrative or financial expertise with Village residents who are duly qualified to hold such positions. The Board further finds that it is authorized to appoint qualified residents of Orange County outside of the Village to said offices pursuant to § 3-300 of the Village Law. The Board further finds that it is authorized under said § 3-300 and § 10 of the Municipal Home Rule Law to expand such residency requirements to allow residents of Orange County to be eligible for appointment to said offices.

§ 58-2 Residency within county required.

- A. Notwithstanding any other general or special law, no person shall be eligible to be appointed to or hold office of the Village Clerk, Deputy Clerk, Village Treasurer, Deputy Treasurer, Village Assessor, Deputy Assessor, Village Court Clerk or Assistant Court Clerk who is not a citizen of the United States, is not at least 18 years of age and is not either a resident of Orange County, New York, or of any village, town or city located within Orange County at the time of such appointment. No person shall be eligible to be appointed as an election inspector in the Village of Monroe unless such person is a resident of Orange County.
- B. This section shall change or supersede § 3-300, Subdivision 2, of the Village Law, as last amended, and § 3 of the Public Officers Law, as last amended, to the extent that the provisions thereof conflict with or are contrary to the provisions of this article.

§ 58-3 When effective; applicability.

This article shall take effect immediately upon filing with the Secretary of State of the State of New York and shall apply to all persons currently holding the positions of Village Clerk, Deputy Clerk, Village Treasurer and Deputy Treasurer as well as any persons hereafter appointed to fill such offices.

Section 4. Supersession, of Inconsistent Laws. The Village Board of Trustees hereby declares its legislative intent to supersede any provision of any local law, rule, or regulation and any provision of the state Public Officers Law, Village Law or other special law that may be declared inconsistent or in conflict with this local law. The courts are specifically requested to take notice of this legislative intent and apply such intent in

the event the Village has failed to specify any provision of law that may require supersession. The Village Board hereby declares that it would have enacted this local law and superseded such provision had it been apparent.

Section 5. Severability.

If any section, part or provision of this local law or the application thereof to any person, property or circumstance is adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the section, part, provision or application directly and expressly adjudged invalid and shall not affect or impair the validity of the remainder of this local law or the application thereof.

Section 6. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State.

PUBLIC COMMENT: # PRESENT 6 TIME: 7:40PM

Resident Lorraine Loening was very pleased that a female Police Officer was appointed to the Monroe

Police Department tonight.

She also expressed her concerns with a Facebook post about Police Dispatch. The Mayor said there is no story, just a discussion, and there is nothing to share with the public. The Mayor stated that this Board would never put the public in harm's way.

Lorraine wanted to know why it seems that most SRO's in the schools around here are retired Monroe PD Officers and what was the criteria to become an SRO. The Mayor explained that the criteria to be an SRO is you must be a certified Police Officer. The SRO's are part-time with no benefits, so a retired Officer is a good candidate and the school is happy to have an Officer that already has a strong bond with the community.

A letter was received and read into the Minutes by Mayor Dwyer:

Good Evening All,

I am submitting a written comment for the public participation portion of tonight's meeting. After viewing a post that surfaced regarding the Monroe Police Department getting rid of the overnight dispatcher position, I was astonished that a proactive, community-driven department in a place I call home would do this.

As a retired law enforcement officer in Orange County, this is horrible for our Village for many reasons. First, and most important for the safety of all residents, calls for service that come through 911 will be delayed to Officers that respond out, even if they have in-car computers. In my experience, I have been to many significant incidents where after being dispatched by my department's dispatcher, I would arrive on-scene, and then, after being on-scene for some time, first hear the polling tones from the county requesting my response. With the ability of the dispatcher to see the call first, I was already advised, responded, and called out on-scene before county operators wholly entered the incident on multiple occasions. This is no discredit to them, just the system that fails them. To this day, calling the department's seven-digit line for police matters yields faster help. With the removal of overnight dispatch, this would not be the case.

Additionally, having the door to the police department closed and locked for the overnight hours was shocking. Now while there might not be many people who walk into a department at night, from my experiences as an Officer, those who do desperately need help.

Many other reasons prove this change is detrimental for our Village, but the ones above are the top two that are dangerous. I call on the board to reconsider this change and consider our public safety.
