A Public Hearing was held on Tuesday, May 3, 2022 in the boardroom of the Village Hall, 7 Stage Road, Monroe, NY at 7:00 PM to review a proposed Local Law entitled "Chapter 43, Vehicle and Traffic." The proposed local law would increase the minimum and maximum fines for speeding within the Village and modify parking meter regulations.

On a motion by Trustee Karl, seconded by Trustee O'Connor, and carried, the public hearing was opened at 7:00 PM.

There were 4 people from the public present for the public hearing. There was no written correspondence received. The public hearing was left open for 10 minutes.

Trustee Karl expressed concerns for overnight parking in the downtown business district. Attorney Terhune said that she was not instructed to add anything to the law and that we could leave the Public Hearing open until the next meeting to make changes to the proposed law.

With no further comments or questions, on a motion by Trustee Karl, seconded by Trustee Behringer and carried, the public hearing was left open until May 17, 2022, at 7:10 PM.

BOND REDUCTION – SMITH FARM CONSTRUCTION – PHASE 1 - CONTINUED: (Minutes 4/5/22, 4/19/22)

On a motion by Behringer, seconded by Ferraro, it was:

For discussion, Trustee Karl has concerns for the location of water shut off valves. Mayor Dwyer spoke with the Engineer and Counsel and questioned the placement of the water valves, are they in the proper location on the easement and if we have access to a water valve on private property. The are some open issues that need to be addressed. Trustee Karl noted the water shut offs are shown to be in the easement on the approved site plans, but are actually not located on the easement by field observation. For the purposes of the bond reduction, the scope of work described has been completed so there is no reason not to accept the Engineer's recommendation. RESOLVED, the Board of Trustees accepts the recommendation of the Village's Engineer, Lanc & Tully, John O'Rourke, P.E., Project Manager, and approves the reduction of the bond held for the Smith Farm Construction – Phase 1. With a large portion of the work completed to date, Lanc & Tully recommends a reduction of work remaining to \$64,090.50. Lanc & Tully recommends a limited reduction in retainage held by the Village to \$50,000.00 for a total bond amount of \$114,090.50.

Alessio Melchiorre, a retired employee, spoke to the Board about adding his wife onto his health insurance. His wife currently has insurance with the Monroe-Woodbury School District and her insurance may not be available any longer. Alessio has contacted the Treasurer and the Board for an answer as to whether she can be added to the health insurance as he is a retired employee. He is requesting an answer from the Board or Treasurer to adding a dependent in seven days, Tuesday, May 10, 2022.

Dan Burke, resident, welcomed the new Trustees and told them to enjoy their terms. He agreed with the raises and felt that the Board is still underpaid. He questioned a traffic light for Gilbert Street and 17M. Attorney Terhune explained that the Village agreed to give a certain amount of money towards the traffic light along with Crystal Run and Smith Farm. NYSDOT did the required review of the traffic and a turning lane would need to be added if a traffic light was to be installed. A turning lane is expensive and nobody has stepped up to pay the additional fees. Mr. Burke also brought up that the previous Board denied the YMCA an entrance to 17M. He commented that where Route 208 hits North Main and Schunnemunk there should be a traffic circle. The Mayor agreed and said that intersection is dysfunctional and needs to be corrected.

On a motion by Trustee Behringer, seconded by Trustee Karl, and carried, following a 5-minute recess, the Board convened in Executive Session at 8:20 PM for discussion of Attorney Client.
