# VILLAGE OF MONROE ZONING BOARD OF APPEALS PUBLIC HEARING July 12, 2022 Via Zoom

The Planning Board strongly suggested that 123 and 125 Elm Street be merged into one property. If that is done less variances will be needed from this Board. There is still work that needs to be done to the site plan before this project can move forward with either Board. Mr. Mann stated he will submit an amended application to the Board when he is ready. Attorney Naughton stated that the public notice would need to be re-published for an amended application. Chairman Baum stated the Board can adjourn this public hearing and will re-notice the public hearing when the amended application is ready to be heard. Mr. Mann agreed with this. Chairman Baum polled the Board to see if anyone objected. No Board members objected.

When the amended application is submitted, the application will be re-noticed for publication and a public hearing will be scheduled at that time.
