WHEREAS, on November 26, 2021 Governor Hochul signed Executive Order 11 which declared a state disaster emergency for the entire State of New York; and

WHEREAS, on August 13, 2022 Governor Hochul signed Executive Order 11.9 which continued the state disaster emergency as set forth in Executive Order 11 through September 12, 2022.

PLEASE TAKE NOTICE that the Village of Monroe Zoning Board of Appeals will be using a remote meeting protocol for its September 13, 2022 Meeting beginning at 8:00 pm through the use of Zoom, a platform which will enable residents to watch a livestream of the meeting on the platform or to call in and listen to the meeting in compliance with the Open Meetings Law.
