The first of the bi-monthly meetings of the Board of Trustees was held on Tuesday, January 7, 2025 at 7:00 PM in the Boardroom of the Village Hall, 7 Stage Road, Monroe, New York. Mayor Neil Dwyer called the meeting to order and led in the pledge to the flag. Emergency exits were announced.

PUBLIC HEARING 01.07.2025 - 7:00 PM

INTRODUCTORY RESOLUTION OF 2025 – PUBLIC HEARING - INTRO TO RESOLUTION – TRAFFIC REGULATIONS – PROHIBITING VEHICLE PARKING OR STANDING ON PROSPECT STREET

A Public Hearing was held on Tuesday, January 7, 2025 in the boardroom of the Village Hall, 7 Stage Road, Monroe, NY at 7:00PM to review a proposed Resolution, titled Resolution #1 of 2025 – Traffic Regulations – Prohibiting Vehicle Parking or Standing on Prospect Street. The Village Board of Trustees finds and determines that vehicles parked or standing along the entire length of Prospect Street, therefore, pose a threat to the health and welfare of Village residents and visitors.

Present: Mayor Dwyer, Trustees Behringer, Ferraro, Karl, and O'Connor Also present: Attorney Terhune and Clerk Zahra

On a motion by Trustee Behringer, seconded by Trustee Karl, and carried, the public hearing was opened at 7:00 PM.

There were 4 people from the public present for the public hearing. There was no written correspondence received. The public hearing was left open for 7 minutes.

Patty Kasch, a resident of Prospect Street for over 40-years says the parking has become a safety hazard for kids getting on and off the bus. Cars are parked on both sides of the street making it impossible for an emergency vehicle like an ambulance or firetruck to get up the hill. Prospect Street is a residential street, not a commercial parking lot for the business located across the street.

Edwin Saldago says his uncle drives a car with no back-up camera and almost hit a parked car coming out of his driveway. Parking on the street has created a hazardous condition for the residents that reside on Prospect Street.

Trustee Karl expressed concerns for parents waiting in cars to drop their children for the bus, would that be breaking the law. Attorney Terhune explained that standing with good reason for a short period of time would not be breaking the law.

Residents of this area expressed their concerns and asked when the resolution would take place. Mayor Dwyer said once the Board adopts the resolution, signs will be placed so that the Police Department will have the tools to enforce the traffic regulation.

Dear Members of the board,

I apologize for not been able to attend this meeting.

I own a home on Prospect Street.

I hope you will consider the issue of parking on Prospect Street. I very much respect the hardworking people of Monroe Automotive, but we need to find a better way to deal with their lack of space. In the past, I have ignored the inconvenience of parked cars, and the difficulty in exiting and accessing Prospect Street. However, it has become much worse, and now is downright dangerous. I have had a couple of close calls trying to navigate in and out of my street.

It is a tight turn coming into the street, and if a car is trying to exit, they must reverse in order to allow a car to enter from Spring Street. This also causes a delay in entering the street and the drivers on Spring Street are not very happy about it (loud honking, or passing across the double yellow line)

Furthermore, some of the residents of Prospect have children and during inclement weather should be able to wait for the school bus in their cars, without the parked cars on the other side which do not allow more than one car to pass in the middle.

The customers of Monroe Automotive also will park on the shoulder of Spring Street (clearly marked NO standing), and sit in their cars waiting to be serviced, blocking our view of incoming traffic as we exit the street.

I would like to suggest that the people of Monroe Automotive clear out their back parking lot to make room for their clients.

I hope you can find a solution to our problem.

WHEREAS, the Village Board of the Village of Monroe, New York ("Village Board") duly noticed a public hearing held on January 7, 2025; and

WHEREAS, the Village Board solicited public comment during said public hearing on January 7, 2025; and

WHEREAS, the proposed resolution modifies Traffic Regulations, Prohibiting Vehicle Parking or Standing on Prospect Street; and

NOW, THEREFORE, BE IT RESOLVED that:

1. The above "WHEREAS" paragraphs are incorporated herein by reference.

2. The Resolution, Traffic Regulations, Prohibiting Vehicle Parking or Standing on Prospect

Street as attached is adopted as Resolution No. 1 of 2025 of the Village of Monroe on January 7, 2025.

3. The Village Board hereby directs the Village Clerk to take all steps to process and file said

Resolution.

4. This Resolution shall be effective immediately.

VILLAGE OF MONROE BOARD OF TRUSTEES

RESOLUTION TRAFFIC REGULATIONS, PROHIBITING VEHICLE PARKING OR STANDING

ON PROSPECT STREET

WHEREAS, after consultation with the Chief of Police of the Village of Monroe Police Department,

the Board of Trustees determined that vehicles parked or standing along the entire length of Prospect Street,

therefore, pose a threat to the health and welfare of Village residents and visitors; and

WHEREAS, New York State Village Law 4-412 confers authority on the Board of Trustees to manage

village property including specific authorization to take all actions not inconsistent with general law and the

provisions of the New York State Constitution to protect the safety, health, comfort and general welfare of

Village inhabitants; and

WHEREAS, Section 43-9A of the Village Code authorizes the Board of Trustees by duly enacted

resolution to prohibit parking on Village streets; and

WHEREAS, a duly noticed public hearing was held on January 7, 2025, at which hearing members

of the public were afforded the opportunity to comment on the proposed resolution to prohibit parking along

the entire length of Prospect Street as set forth herein; and

WHEREAS, after hearing from all those wishing to comment on said proposed resolution, the public

hearing was closed; and

WHEREAS, because the prohibition of parking on Village Streets is not an "action" under the State

Environmental Quality Review Act ("SEQRA") it is not subject to environmental review.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Monroe

hereby prohibits the parking or standing of any and all vehicles along either side of the entire length of

Prospect Street including, without limitation, on the roadway, in the shoulder, and within the Village right-

of-way.

BE IT FURTHER RESOLVED, that said prohibition shall be added to the "no parking" and "no

standing" list maintained by the Village Clerk and shall be enforced by the Village of Monroe Police

Department.

BE IT FURTHER RESOLVED, that all actions and funds necessary to effectuate the intent of this

resolution such as posting signs and erecting guardrails shall be undertaken upon further consultation between

the Chief of Police, the Village Department of Public Works and the Mayor.

<u>INTRODUCTORY LOCAL LAW OF 2025 – OVERRIDE TAX LEVY LIMIT ESTABLISHED BY</u> GENERAL MUNICIPAL LAW 3-C & SCHEDULING OF PUBLIC HEARING:

The Board thanked the Highway Department for the good work they do keeping our roadways safe. They also commented on the water main break that occurred during a house fire on Cromwell Hill Road. They worked quickly and efficiently to get the job done. They are top shelf!
