Mayor Dwyer said the playground build continues and the play equipment should be done by Friday, then the finishing up will take place. He thanked the volunteers, Board, and Department of Public Works for their help.

Trustee Behringer commented that the weather has not cooperated for the Airplane Park rebuild and is very excited for the completion of the park.

Trustee Ferraro thanked the many local restaurants that have donated food for the workers and volunteers. They put the community in front of profit. Please be sure to support our local restaurants.

Trustee Karl said kudos to all the folks participated in Clean Sweep, they did a great job. Trustee Karl announced that vendor applications are now being accepted for the Independence Day Celebration, not-for-profits will be accepted first, then it is open for the for-profit organizations. He also commented on the sign status for Stage Road in respect to the speed and commercial traffic, when will they be put up. Trustee Karl also inquired if anything more had been discussed in regards to the parking lot at 1 Stage Road. He asked about the streetlights. Mayor Dwyer said there is a meeting scheduled for next week on this very topic. He would also like a letter to go out the Public Service Commission regarding the double poles in our Village, as per our Village Code they should be removed. Trustee Karl also inquired about

the 2026 Community Development Grant. Any ideas on what we could apply for. Mayor Dwyer said the grant is directed toward low-and-moderate- income map which currently includes the trailer park and Hidden Creek for the Village of Monroe. Trustee Karl would also like a letter written to the Town of Monroe Supervisor and Gedayle Szegedin, Village of Kiryas Joel, for an update on the Kiryas Joel Salt Shed located within the aquifer of Well #4 in Smith's Clove Park, as the sodium chloride levels have been rising.

Nora Staffanell, Village resident spoke:

I am the initiator of Indivisible Monroe/Hands Off Hudson Valley.

We had a tremendous turnout of over 70 people at this past weekend's pro-democracy event.

Monroe Republicans, Democrats, and Independents all came together as Americans to protest the un-American actions of the Trump regime.

We will be holding our next event on May 17th from 1 to 2 pm at the corner of Lake Street and 17M. I would like to invite everyone here to attend. Our events are held rain or shine.

People have different reasons for attending these events. I'd like to briefly share with you one reason that I heard from several residents of the Village of Monroe who attended this weekend's demonstration and who are alarmed by the government's treatment of immigrants.

I personally am alarmed to see the graffiti on the Heritage Trail, which has been painted over and reappeared several times. I would like to see the removal of these hateful words and the addition of a "Smile - You're on camera" sign nearby, which is way cheaper than an actual camera.

Given the number of Monroe residents with an undefined legal status, I would like to encourage this Board and the Village Police Department to publicly commit to upholding the Constitution, and specifically the 5th and14th Amendments of our Constitution, which hold that constitutional rights apply to both citizens and noncitizens in the United States.

Thank you for listening to the concerns shared with us by Village of Monroe residents. I have the utmost respect and gratitude for our men and women in the Village Police Department, as well as our elected officials. Thank you for your service to the public. And I hope to see you at the next event on Saturday, May 17th, at 1 pm over at the corner of Lake Street and 17M.
